Substantial Amendment to the 2014 Annual Action Plan

Pursuant to HUD regulations in 24 CFR 91.105(c)(2) and the Consolidated Plan Citizen Participation Plan adopted by the Mayor and City Council on July 9, 2014, the City of Harrisburg hereby gives notice of proposed amendments to the 2014 Annual Action Plan for the funds received from the U.S. Department of Housing and Urban Development.

Mayor Eric Papenfuse invites citizens to provide public comment on a substantial amendment to the City of Harrisburg's FY-2014 Annual Action Plan to correct the funding awards received from HUD and revise several previously approved allocations and funding sources.

The total award amounts for CDBG and HOME included in the 2014 Annual Action Plan approved by City Council were incorrect. The City has received federal entitlement funds in the following amounts:
