

MECHANICAL DEVICE LICENSE ORDINANCE, ARTICLE 371, CITY OF HARRISBURG

Effective January 1, 1983, all Distributors placing mechanical devices at any location within the City of Harrisburg will be required to obtain a "Distributor's License" to operate within the City of Harrisburg.

According to the above-mentioned Ordinance, Mechanical Device and Distributors are defined as:

"Mechanical amusement device" includes any manual, electrical or electronic device, machine or apparatus whatever, other than a juke box, which upon the insertion of any money metal or paper in nature, slug, token or other monetary substitute, may be operated for use as a game of entertainment, amusement, chance or challenge, whether or not a score is registered, or a prize is offered.

"Distributor" includes any person who shall, either as owner or agent, sell, lease, lend, deliver or furnish to, or place or cause to be placed in the possession of any operator within the City of Harrisburg, any mechanical device, machine or apparatus whatsoever other than a juke box, which, upon the insertion of a coin, slug, token, plate or disc, may be operated for use as a game, entertainment or amusement, whether or not registering a score and whether or not a prize is offered.

Enclosed you will find an application for such a license for your completion. Please return this application with payment in the amount of \$350. A license will be sent to you in lieu of the annual \$50.00 Business Privilege and Mercantile License.

Please note that even though this license is in lieu of the \$50.00 Business Privilege and Mercantile License; however, you will still be responsible for paying and filing the annual Business Privilege and Mercantile Tax based on your gross receipts.
